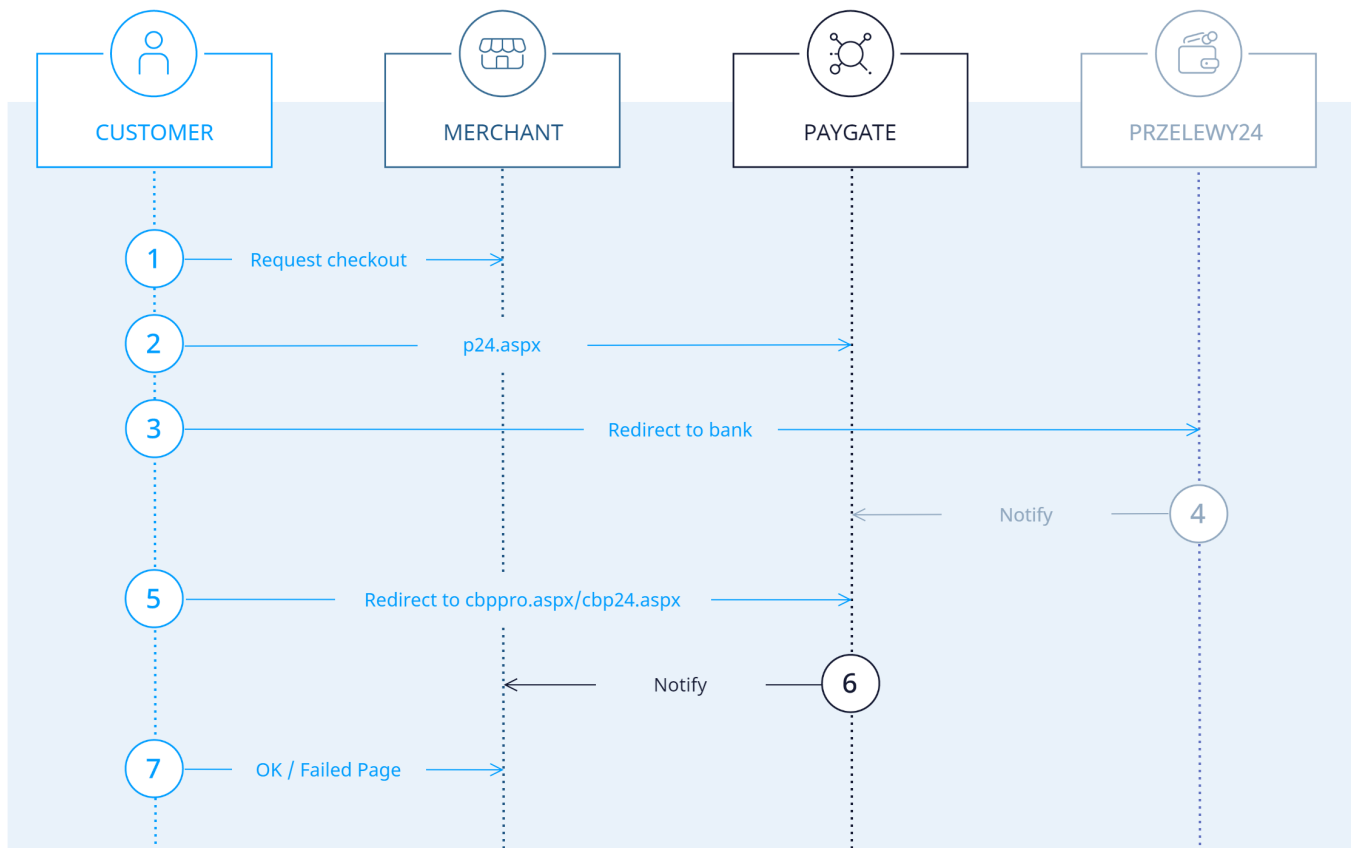

<b>Info</b>	Przelewy24 is an online banking method for Poland. It uses online bank authentication for account postings in real-time. Przelewy24 is supported by 18 large banks and reaches 95 % of the polish customers in online banking. The system has no transaction limit and directs customers via its online banking environment directly to the payment processing.

# Batch processing via the interface

Basic information about using Batch files and about their structure can be found in the Batch Manager manual. Within batch processing not all functions are available which are usually available for the online interface.

This section describes the parameters which must be transferred within the data set (**Record**) for executing credits with Przelewy24 and which information can be found within the response file about the payment status.
